**Barker Park**-27 acres, west of Shiocton on Old 54 Rd. Boating access to the Wolf River, picnic area.

**Buchman Access**-2 acres, north of Hortonville on Cty. Rd. M. Boating access to the Wolf River, roadside park.

**Koepke Access**-5.45 acres, boating access to the Wolf River and picnic area.

**Stephensville Access**-1.1 acres, on Cty. Rd. S. Boating access to the Wolf River.

**Wolf River Shoreline Fishing Area**-South of New London on U.S. Hwy. 45 By-Pass.

**Wolf River Shoreline Fishing Area** - West of Stephenville on Highway S.

**Outagamie County Pet Exercise Area**-17 acres, located at the corner of French Road and Highway 00, fenced in area where dogs can run and socialize off leash.

## HISTORICAL SKETCH

Outagamie County, with its present boundaries, was detached from Brown County in 1851. The Menominee Indians in 1831 and 1836, under the Treaty of Cedars, deeded about 4,000,000 acres to the white man, part of which became Outagamie County. The name is derived from an Indian tribal word meaning “dwellers on either shore” or “dwellers on the other side of the stream.” Most French explorers passed through this area as it is located on the Fox River-Lake Winnebago waterway. Augustus Smith, a senator, University of Wisconsin regent, and well-known settler in the area, helped organize the first hydro-electric power plant and also the electric street-car line in 1886, believed to be the first in the world. The Appleton Edison Light Association in 1882 was the first organization in the world to distribute power commercially. The Smith House was the second in the United States to be wired for electricity. After the Civil War, fur trading, logging and cheese-making were widespread. Today, manufacturing plants for food, paper and allied products are predominant. Appleton, the county seat, is the home of Lawrence University, Edna Ferber and Harry Houdini.
