Outagamie County – 8:30 a.m. on April 13, 2012, at County Board Room, County Administration Building, 410 S. Walnut Street, Appleton, WI

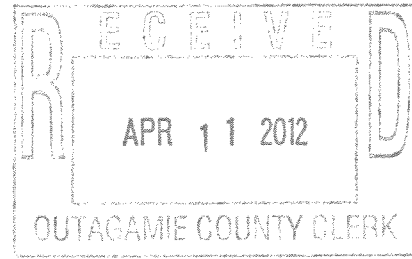


Ann Muenster knows of her own knowledge that there may have been irregularities in the conduct of the election at the polling site in Appleton at Mt. Olive Ev. Church.

Ann Muenster requests a recount of all wards within Supervisory District 20.



