I also provide assistance with the day-to-day operations of the Emergency Management Office. I am an instructor for courses in public safety, public information, the Incident Command System (ICS) and the National Incident Management Systems (NIMS). Each year, I write and assist with 45+ Aid to Firefighter Grants. I have helped bring millions of dollars into Grant County and the region through these efforts and through Federal and State Disaster Declarations.
