

***RESOLUTION NO.: 123--2012-13***

TO THE HONORABLE, THE OUTAGAMIE COUNTY BOARD OF SUPERVISORS

LADIES AND GENTLEMEN:

***MAJORITY***

1           The Wisconsin Department of Transportation (DOT) has nominated the US 10/Wisconsin  
2           441 project as a potential candidate for delay in the DOT budget submitted to Governor  
3           Walker. This project has significant impact to the economic health of the Fox Valley and  
4           the counties of Winnebago, Calumet and Outagamie; along with providing a valuable  
5           transportation link to travelers and commerce working and traveling in and around the  
6           area. The existing corridor carries considerably more volume than can be efficiently or  
7           safely accommodated.

9           NOW THEREFORE, the undersigned members of the Highway & Solid Waste Committee  
10          recommend adoption of the following resolution.

11           BE IT RESOLVED, that the Outagamie County Board of Supervisors on behalf of the counties  
12          of Winnebago, Calumet and Outagamie jointly request that full funding for the US 10/Wisconsin 441  
13          project be restored, and

14           BE IT FURTHER RESOLVED, that the proposed schedule for the project be fully restored and  
15          the funding dedicated so as to continue the progress of the project and bring about the reconstruction as  
16          planned by the Department of Transportation, and

17           BE IT FINALLY RESOLVED, that the Outagamie County Clerk be directed to forward a copy  
18          of this resolution to all Winnebago, Calumet and Outagamie County State Legislators, Wisconsin  
19          Secretary of Transportation Mark Gottlieb, Governor Scott Walker and the Outagamie County Highway  
20          Commissioner.
