

ORDINANCE NO.: P--2013-14

TO THE HONORABLE, THE OUTAGAMIE COUNTY BOARD OF SUPERVISORS

LADIES AND GENTLEMEN:

MAJORITY

1
2 The Highway and Solid Waste Committee is recommending a speed limit change on
3 CTH "JJ" from Highway 47 to 0.10 miles east of Lightning Drive. Currently, there is a
4 posted speed limit of 45 mph. This ordinance requests reducing the speed limit from 45
5 mph to 35 mph, as noted on the attached map.

6
7 NOW THEREFORE, the undersigned members of the Highway and Solid Waste Committee
8 recommend adoption of the following ordinance.

9 BE IT ORDAINED, that the Outagamie County Board of Supervisors does amend Section 36-91
10 "Speed Zones Established" of the Outagamie County Code of Ordinances to read as follows:

11 **Sec. 36-91. Speed zones established.**

12 The speed limit on the following streets or portions of streets shall be as indicated:
13 (***additions are bold and italic***, deletions are struck through)

14 (3) *Thirty-five miles per hour.*

15 CTH "JJ." From ~~Ballard Rd. west 0.35 of a mile.~~ ***Hwy 47 (Richmond St to 0.10***
16 ***miles east of Lightning Drive.***

17
18 (5) *Forty-five miles per hour.*

19 CTH "JJ." From ~~Holiday Dr. to 0.2 of a mile east of CTH "E."~~

20 CTH "JJ." From ~~0.20 miles east of CTH "E" to 0.35 miles east of CTH "E."~~

21 CTH "JJ." From ~~0.35 miles west of Ballard Road to 0.05 miles west of Apple Creek~~
22 ~~Road.~~

23 CTH "JJ." From ~~0.45 of a mile west of Ballard Rd. to 0.05 of a mile west of Apple~~
24 ~~Creek Rd.~~

25 CTH "JJ." From ~~0.05 miles west of Apple Creek Road to~~ ***CTH "A." to Hwy 47***
26 ***(Richmond St)., and***

28 BE IT FURTHER ORDAINED, that this ordinance shall be in full force and effect upon
29 approval by the Outagamie County Board of Supervisors and published per §59.14 and §66.0103 and
30 upon erection of standard signs giving notice to the aforementioned permissible speed, and

1 BE IT FINALLY ORDAINED, that the Outagamie County Clerk be directed to forward a copy
2 of this ordinance to the Outagamie County Highway Commissioner, the Outagamie County Sheriff, and
3 Municipal Code Corporation.
