

**Oneida-Hobart Drainage District  
Annual Meeting Minutes  
October 4, 2017**

President Kramer called the meeting to order at 7:45 p.m. He introduced the Outagamie County Drainage Board members. Present: Greg Nettekoven, Jason Van Eperen, Mike Van Asten. Gerald Vander Heiden

Also present: Nancy Christensen, Administrative Assistant and Jeremy Freund, Land Conservation Department. 1 resident was in attendance (see sign-in sheet)

The Board meets every first Tuesday of the month at 8:30 a.m. at the Outagamie County Highway Department, 1313 Holland Road, Appleton. Anyone with concerns may come to this meeting and bring them before the Board or contact any member at any time. Minutes and agendas are posted on the Outagamie County website under the Land Conservation Department.

**Minutes of the 2016 Annual Meeting** – Motion made and seconded from floor to accept the minutes

**Presentation of projects** – Spraying has been completed this year. Dredging project is proposed for 2018. A question was asked about the area that is not sprayed due to organic plantings to control weeds, how is it maintained? If property owner doesn't maintain the ditch/buffer for weeds, the Board would have a special clearing of the weeds which would be charged back to the property owner.

**2016-17 Financial Report** – The District had a deficit of \$894 the end of 2016 . After receipt of the special assessment of \$22,178 there is a balance of \$21,283 as of January 1, 2017. January 1 thru August 31, 2017 expenses were \$1,893 resulting in a current balance of \$19,390. Motion from floor to accept the financial report.

**2017 Assessment Rates paid in 2018** - Discussion was held on the special assessments and if the Oneida Tribe is being assessed. There is an agreement with the Oneida Tribe to work together and they have been supportive in the past. They have been assessed in the past years.

There is major work that needs to be completed from Vans, McCabe, and Verhassel Roads. Recommended increasing the rate to \$4.00 per acre/\$40 minimum.
